## tructions to Students

- 1. Be in uniform if not, get Exam Cell approval.
- 2. Be Punctual. Late entry permitted only till the first 15 minutes. The exam hall will be closed between 5 minutes before the commencement of exam.

Doors will re-open for late comers <u>10 minutes after</u> commencement of the exam

- 3. You may leave the hall after the first 30 minutes of the exam.
- 4. Wear your identity card. If not in possession, get exam cell permission.
- 5. Please switch off your mobile phones and keep it in your bags/hand it over to the invigilator as soon as you enter the examination hall. If any electronic gadget is found to be possessed by the student, the same shall be confiscated and submitted with the Academic Cell along with the identity card/Admit Card.
- Please occupy your seat at the allotted place in the examination hall at the strike of the first announcement, but not before. <u>Answer booklets will be issued by the invigilators</u> <u>only</u>. <u>DO NOT FORGET</u> to fill all the appropriate columns and Sign on the facing sheet of the answer booklet.
- 7. Keep your Admit Card on the table. Get permission from the exam cell, if not in possession.
- 8. The question papers will be distributed at the strike of the second announcement. Invigilator will call up the question paper course code and title. The respective students must stand up and receive the question paper. Please make sure that you are given the right question paper. Please do not write anything on the question paper except your roll number.
- 9. You are not permitted to pass the question paper, much less the answer book, to other students. You are also not allowed to borrow calculators, or any other materials from other students
- 10. Students are not allowed to stand outside the examination hall after the first announcement. Students are generally not permitted to enter the examination hall after the second announcement. Genuine late comers will be allowed to enter the hall, but only in the first 15 minutes.
- 11. Students are not permitted to leave the examination hall in the first half an hour.

## 12. Any case of copying, malpractice, discussion shall be reported to the Academic Cell.

Malpractice: The following will be considered as malpractice:

- a) Writings on the desk relevant to the examinations.
- b) Verbal or oral communication to neighbouring candidate.
- c) Objectionable writings in the answer book.

d) Possession of any incriminating materials inside the examination hall (Whether used or not).

e) Written or printed materials, bits, writings on scale, calculator, Handkerchief, Hall Ticket, handbooks, Dress or any part of the body, possession of organizer etc,

f) Copying from neighbour.

g) Possession of answer book of another candidate.

h) Giving answer book to another candidate/taking answer book from another candidate.

i) Exchange of question papers and other materials with some answers.

j) Misbehaviour in the examination hall (Disobedience, unruly conduct in the examination hall, threatening the Hall Superintendent/Chief Superintendent and other examination officials), carrying mobile phone.

k) Forgery in any part of records submitted.
